**Sub: Specification for Ultra Low Temp Vertical type -86 deg C deep freezer with accessories**

Sealed tender in two bids system (**Technical Bid &Price bid**) is invited from bonafide, resourceful and eligible manufacturers/exclusive distributors of "**Specification for Ultra Low Temp Vertical type -86 deg C deep freezer with accessories**".

Part I (Technical Bid) of the tender should contain technical details and commercial terms and conditions and Part II (Price Bid) should indicate group-wise price as mentioned in the Technical Bid where applicable. The Technical Bid and Price bid are to be submitted in two separately sealed envelopes distinctly marked accordingly and both to be put inside another envelope, which should be sealed and super scribed with tender notice no. and due date. The bidders may submit bids duly signed in their own letterheads.

Complete tender bids should reach the office of the **Department of Physical Chemistry, Indian Association for the Cultivation of Science, 2A & 2B Raja S. C. Mullick Road, Jadavpur, Kolkata 700032** or on before the scheduled date & time specified below.

The technical bids will be opened first to evaluate the technical specifications of the equipment thereafter, the Price bids of only technically qualified bidders will be opened. The date of opening the Price Bids will be intimated to the short-listed bidders at their contact addresses. The rest of the bids will be rejected.

**A). TECHNICAL BID:**

**Specification for Ultra Low Temp Vertical type -86 deg C deep freezer:**

1. Type : Vertical
2. Temp. Range : - 50 deg C to -86 deg C
3. Volume : Above 360 liters
4. Control : Microprocessor controlled
5. Refrigeration system : Air cooled , CFC free refrigeration system with 2 nos. 1 H.P. Compressors
6. Display : Eye level , Digital LED display
7. Electrical system : Automatic low voltage surge protection with voltage buck/boost
8. Interior : Stainless steel with rounded corners for easy cleaning .
9. Exterior Cabinet construction : Heavy gauge, cold-rolled steel exterior construction with a powder coated paint finish that resists chipping and rust .
10. Insulation : 5 inch foamed – in – place, polyurethane insulation.
11. Vacuum relief port : Allows easy and quick access after door opening.
12. Inner door : 5 independent interior compartment doors to reduce cold air loss, improve temperature recovery after door closing and to help maintain cabinet temperature during door opening .
13. Shelves : 4 sturdy, solid stainless steel shelves to create 5 interior 14. compartment
14. Filter : Easy to clean dust filter
15. Access Port : Two 1 inch ( 25 mm) access port standard
16. Centralised Information Centre : Microprocessor controlled monitoring system ensures all controls & displays are easy to reach and read
17. Security Key Lock : Standard with unique key option
18. Pad Lock Compatible : Standard.
19. Door Lock : Sturdy integrated key lock with handle for single hand operation.
20. Power requirements : 230 V , 50 Hz, single phase .
21. Optional accessories : Racks, Boxes , Dividers and CO2 back up system.
22. After-sales service : Prompt and efficient after-sales service should be available from Kolkata

23. Warranty : 2 years on basic Freezer & additional 2 years on compressor.
24. Accessories ( 2 sets) : Inventory system incl. rack , box , divider should be quoted.
25. A 5 KVA online UPS with 30 minutes back up should be provided locally at the time of installation.
26. F2 Pipette, range 0.5 – 5 ul , 20-200 ul & 100-1000 ul should be provided.

**Important notes:**

- Equipment should be offered with 24 months warranty followed by additional 2 years on compressor.
- Vendor should arrange for the supply of suitable Online UPS with at least 30 minutes back-up
- Bidder providing misleading or wrong information will be disqualified
- All technical claims of the Bidder should be supported by product catalogue, public website of the manufacture.

**B). PRICE BID:**

The financial bid should be superscribed as "Price Bid" on the outer cover of the envelope.

1. Price Bid: The price bid indicating (item-wise) price for the item(s) mentioned in the technical bid should be kept in a separate sealed envelope duly superscribed as "PRICE BID" on the outer cover of the envelope as already detailed above. The price bids of only technically qualified bidders will be opened and they will be intimated the date and time of opening of price bids at their email id-(s). Rest of the bids will stand rejected.
2. Price: Price to be quoted both on FOB/CIF basis for foreign currency or in Indian currency. Name of the particular port from where our authorized forwarder will lift the consignment must be mentioned clearly with FOB price.
3. Bid Security (EMD): An Account Payee Demand Draft of Rs. 15,000/- (Rupees fifteen only) in the name of "Indian Association for the Cultivation of Science" is to be furnished by the bidders, as Bid Security money or Earnest Money Deposit (EMD).
4. The Demand Draft for the Bid-Security money should have at least 45 (forty five) days validity period after the opening of the Bids.
5. In case of non-award of the work the Bid Security money would be returned to the unsuccessful Bidders.
6. Performance Security:

An Account Payee Demand Draft of an amount of 10% of the order value in the name of "Indian Association for the Cultivation of Science" is to be furnished by the successful bidder as Performance security. Performance security money should remain valid for a period of 60 days beyond the date of completion of all contractual obligations of the supplier including warranty obligations. Bid security money will be refunded to successful bidder on receipt of the Performance security money.

**(C) General Instructions:**

1. Incomplete & conditional tenders and tenders received after the due date will be summarily rejected without assigning any reasons thereof. **Specification for Ultra Low Temp Vertical type -86 deg C deep freezer with accessoriess** should clearly be written on the envelope.

2. At any time prior to the bid due date, IACS may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder during pre-bid meeting, modify the bidding documents. The amendment(s) will be notified on the Institute website.

Prospective bidders are advised to occasionally visit the website ([www.iacs.res.in/tender](http://www.iacs.res.in/tender)) for any amendment.

3. Payment: 100 % through letter of Credit; 90% to be released against shipment and balance 10% against successful installation subject to submission of performance guarantee.

4. Warranty: Equipment should be offered with 24 months warranty additional 2 years on compressor.

5. Installation/Demonstration /Application Training at site: Free of cost by the supplier

6. User list: The supplier should provide a list of current users (with contact no, Email address etc) for the quoted item in India.

7. Service facility: Supplier should mention their details of service setup and Manpower in Kolkata who are responsible for after sales support. Response time should be within 24 hours.

8. The tender submitted shall remain valid at least for three months from the date of opening the tender. Validity beyond three months from the date of opening of the tender shall be by mutual consent

9. The tender should accompany a compliance chart. A technical compliance chart should also be provided following the given format:

10. The rate should be inclusive of all taxes, transportation etc. Nothing extra will be paid in addition to the quoted rate.

11. The model number, make, and a printed literature of the product shall be submitted positively.

12. Proposed delivery schedule should be mentioned clearly.

13. Manufacturers/exclusive distributors/vendors should have history of supplying this type of instrument to this or other Scientific Organization.

14. Authorized Dealership Certificate is must in case of principal manufacturing company is not quoting directly.

15. Guarantee certificate, users manuals etc. are to be handed over to the user after successful commissioning of the system.

16. Incomplete tenders will be summarily rejected.
