However, for changes in Govt. /statutory rates of wages/taxes etc., necessary changes will take place against demand.
- 3 In the event of failure on the part of the contractor to timely deploy requisite manpower or to perform any job related to scope of this work due to any reason whatsoever fitting penalty may be imposed as per assesment of IACS which will be binding to the agency and will be recovered from the monthly bill or otherwise.
- 4 The contractor shall comply with all the provisions of the Minimum Wages Act-1948, Minimum Wages rules 1950, Contract Labour (Regulation & abolition) Act 1970 and other labour laws affecting contract labour that may be brought into force from time to time
- 5 No Child Labour below 14 years of age Shall be allowed to work under this contract.
- 6 Please fill in the ANNEXURE-I form first then put the rate on this Schedule of work.
- 7 Please sign on each page with seal towards acceptance of all NIT conditions before submission of tender document
- 8 Average day/month to be considered as 30.4 days. The same is derived to by dividing 365 days with 12.
- 9 The above quoted rate shall be inclusive of all taxes & duties but exclusive of service tax as will be applicable from time to time. However, bill deduction towards ST& IT, labour welfare cess etc will be made as per rule.
- 10 The Minimum Wages as applibale w.e.f. 01.04.2015 for central sphere has been considered for the labourers who will be governed by the Minimum Wages Act -1948 & Minimum Wages Rules 1950
