**CORRIGENDUM NO-01**

**TENDER NOTICE NO: IACS/ADM-SECURITY/MLS/15-16/24 DATED 10/12/2015**

On the points raised by the representatives of the companies participated in pre-bid meeting held on 21.12.2015, the committee deliberated and resolved the points one by one as under and the modification carried out to the following extant:-

- a) **Page 3/14 of the tender document.**

**Since IACS is the Principal Employer, therefore Committee agreed to issue Form V to the selected agency.**

- b) **Page 3/16 of the tender document.**

**Committee resolved to verify documents with the original ones and allowed to make self attestation at the time of submission of tender.**

- c) **Page 6/20 of the tender document: - 4 (four) Nos. of Metal detectors to be issued by IACS and 2(Two) Nos. to be procured by Agency.**

**Committee agreed as Security Section has 4 Nos. of metal detectors for the purpose.**

- d) **Page 16/16 of the tender document: - Payment of wages in presence of authorized representative of IACS discussed.**

**Since the most of the agencies are making payment of wages to their employees through electronic transaction, therefore, making payment in the presence of IACS SO/IACS representative need not be insisted, but copy of the payment record must be shown to the SO/IACS representative.**

- e) **Page 20/3 of the tender document: - Corporate Identity Card to be issued to its employees by the Agency.**

**Committee firmly insisted to abide by.**

- f) **Cost of Uniform @ Rs. 170/- per month per head to be reimbursed.**

**In order to keep the Guards in good turnout all the times in all weather conditions, committee considered the point and agreed to allow Rs. 170/- per month per head Uniform cost reimbursement initially for one year. However, on grant of subsequent extension of contract it will be admissible for alternate years (i.e. for 1st, 3rd and 5th year only).**

- g) **New Price bid format** to be issued. Only service charge to be quoted by the Agency.

**The Committee agreed to place the Price Bid format giving the present rates of wages/allowances admissible as per Government of India rules. The formats of Financial Bid-Appendix IV (Page 21 and 22) have been modified and uploaded in the IACS website.**

- h) **Eligibility Criteria: Page 3, point 21:** at the end of the sentence **add** "as mentioned earlier".

- i) **Instructions/Guidelines for Tenderers: Page 6, point 20:** at the end of the sentence add -

"failing which a monetary compensation will be claimed from the party through a joint investigation".
