The last date for receiving the tender is **June 25, 2012** up to 1.00 P.M and will be opened on the same day at **3:00 p.m.** in the J C Bose meeting room of the institute. Manufacturers/ exclusive distributors should have past history of supplying this type of instrument to this or other Scientific Organizations.

**Tender Form:** Tender should be submitted to the office of the registrar, IACS, Jadavpur, Kolkata-700032 in plain paper or Letter Head separately in the forms of Technical and price Bids both enclosed in a single envelop.

**A). TECHNICAL BID:**

Technical Specifications for a Scientific Monochromator with control software

Spectral range: Mid-infrared (2.5 – 50 micrometer)

Focal Length ~0.25 - 0.35 m

Groove density of grating: 300-100 lines/mm.

Number of variable slits (micrometer/ computer controlled): 2 (input and output)

Spectral Dispersion: Better than 5 nm /mm

Optimum wavelength: 6 micron

Number of Gratings that can be accommodated on Turret: 2-3

Computer Interface Hi-Speed USB

**Installation/Demonstration /Application Training at site : Free of cost by the supplier**

Warranty: 1 year

Service facility: Supplier should mention their details of service setup and Manpower at Calcutta who will be responsible for after sales support. Response time should be within 24 hours
